This letter reissues the determination for properties and/or structures in the referenced community as described in the Letters of Map Change (LOMCs) previously issued by the Department of Homeland Security's Federal Emergency Management Agency (FEMA) on the dates listed on the enclosed table. As of the effective date shown above, these LOMCs revise the effective National Flood Insurance Program (NFIP) map panel dated September 30, 2005, as revised by the Letter of Map Revision dated July 17, 2006. These LOMCs will remain in effect until superseded by a revision to the NFIP map panel on which the property is shown. The FEMA case number, property identifier, NFIP map panel number, and current flood insurance zone for the effected LOMCs are listed on the enclosed table.
